# TERMS & CONDITIONS OF CONTRACT – FOR CATERING AND LODGING SERVICES IN KENDRIYA VIDYALAYA MATHANA

- 1. The agreement shall be valid initially for a period of 12 Months thereafter it may be extended for a further period one year on performance and on mutual agreement.
- 2. The price list as attached herewith will be made an attachment to this agreement and will be valid for 12 Months. The contractor will supply only such items specifically approved by the PRINCIPAL, KV, Mathana.
- 3. The contractor will be responsible for providing all food and other items mentioned in list.
- 4. In case of any food poisoning/contamination the contractor will be held fully responsible and he will bear all the expenses caused due to food poisoning/Contamination.
- 5. The Contractor will employ adequate number of staff in order to maintain efficiency.
- 6. All persons engaged by the contractor shall be the contractor's own employees and they will claim no privileges from PRINCIPAL, KV Mathana. The contractor will be directly responsible for the administration of his employees as regards general discipline and courteous behavior.
- 7. The contractor will get all his workers medically examined from approved Registered Medical Practitioner recognized by Indian Medical Council, to be free from communicable diseases in addition to general fitness.
- 8. The Contractor will be responsible for cleanliness of crockery, cooking utensils, furniture, fixtures and fittings, etc in the kitchen. The organization will not provide any cleaning materials /dusters, etc. for the same.
- 9. Very high standards of hygiene and cleanliness shall be observed in the running of the kitchen, and connected services by the contractor and workers engaged by contractor including those responsible for collection of used utensils and periodic disposal of waste and refuse.
- 10. The contractor will not take out of the Vidyalaya Premises any articles or stores without a Gate-Pass to be issued by the Canteen in-charge. In the event of failure, to supply the approved items without notice by the contractor, the same will be arranged by the Organization at the Contractor's risk and cost.
- 11. The Contractor shall at his own cost, effect, as required as per the Act, necessary insurance in respect of the staff and other personnel or persons to be employed or engaged by the Contractor in connection with the rendering of the aforesaid services to Kendriaya Vidyalaya Sangathan and shall comply with the provisions of (Regulation and Abolition) Act, Employees Staff Insurance Act, Workmen's Compensation Act, Payment of wages Act, The Employees Provident Fund and Family Pension Fund Act 1952, the other rules regulations and / or statues that may be applicable to them now orthat may be introduced.
- 12. KV Mathana shall have the right to search the Contractor's employees at any time while going out of the office premises and there shall be no grievances expressed/felt on this account either by contractor or his employees. The Contractor will issue ID Cards to the contractor's workers in the format approved by KV Mathana.
- 13. KV Mathana nominees reserve the right to take samples of the edibles/raw material from the Kitchen for the purpose of inspection and testing with a view to maintain the quality. Such samples will however be drawn by authorized person/persons in the manner and as per procedure laid down in PF Act.
- 14. A catering Management Committee will be nominated by KV Mathana to inspect and oversee functioning of Canteen with a view to ensure hygiene and sufficient service in the canteen. In case there are repeated failures or lacuna noticed by the committee due to failure or contractor, the Secretary and / or Chairman of the Canteen Committee, can impose of fine upto Rs. 5000/-at one time to be recoverable from bills due to the contractor.
- 15. Contractor will ensure that hazardous or inflammable or any intoxicating material is not stored in the Kitchen premises.
- 16. A) The contractor shall be responsible for all damages or losses to KV Mathana's property by the contractor himself or his staff and shall be liable to make good any such loss or damage excepting those due to reasonable use or wear and tear or such as caused by and an act of God.
  - B) KV Mathana will not be in any way responsible for any loss or damages accruing to any goods, stores or articles that may be kept by the contractor in the kitchen and other rooms.
- 17. In case of any dispute the decision of Principal, KV Mathana will be final and binding on the Contractor.
- 18. The Catering Contractor will bring all crockery/utensils for the purpose of making serving including Gas Burners.
- 19. All the items of lodging like bedding, pillows, bed sheets, rajai/blankets and other items should be of good quality and hygienic. Items should have been properly washed and neat and clean.
- 20. Working experience in catering in various offices at least of 3 years or more.

- 21. List of Offices or Organization where the catering had been running or presently running.
- 22. Contractor should provide firms PAN Number issued by Income Tax Department along with his quote. No payment will be released without submission of PAN Number. All taxes will be recovered from his payment as per tax provision in vogue.
